## Kids On Track Waiver and Release Form

1. I give permission for my child to attend Kids On Track School Club and Monthly Rally programs.
2. I understand that Kids On Track reserves the right to dismiss any child for behavioral problems at the discretion of the director.
3. I give Kids On Track permission to use any photograph/video of my child for promotional materials including on the Kids On Track website, Facebook page, Youtube channel, brochures, promotional video, posters, or other materials. Please note, no last names will be used.
4. I consent to my child being transported to and from the Monthly Rally in a Kids On Track approved vehicle.
5. I understand that they will be participating in activities including but not limited to: gym games, crafts, lesson times, homework help, snack, singing and dancing.
6. It is my understanding that this program will be properly supervised and instructed by qualified persons, but will require reasonable behavior on the part of my child. I will discuss these things with my child. I assume all personal risks and hazards.
7. I understand that during Kids On Track programming times Christian educational and experiential practices such as Bible stories, scripture verses, Christian songs, puppets and discussion will be integrated in a child friendly, non-coercive manner. Children from any faith background are welcome to attend, however the Christian world view will be presented.
8. In the event that my child requires emergency medical treatment and there is insufficient time or reasonable attempts to contact the parent/guardian or the emergency contacts have failed, I give Kids On Track Association of Edmonton the right to obtain any appropriate medical treatment for my child and will cover the full cost of an ambulance and any other costs entailed.
9. I am bound hereby to release forever Kids On Track Association of Edmonton, its directors, employees and volunteers from all and any liability for injury or damage in the event of an illness, accident of misfortune that may occur to my child or their property at or in transit to or from any activity conducted under the authority of Kids On Track programs. I shall assume financial responsibility for my child's actions which causes damages to the property of others.

## KIDS ON TRACK: CONDITIONS OF ENROLLMENT

1. All children attending any Kids On Track program must have a registration form signed by the **parent/ legal guardian** the first time they attend. If your child is bringing a visitor, the visiting child must have a registration form signed by their legal parent or guardian. You can download extra forms at [www.kidsontrack.org](http://www.kidsontrack.org). **We will not allow any first time visitors without a parent's signature on a registration form.**
2. Bussing is available for Monthly Rallies ONLY and is now offered on a "**book a ride**" basis only. You must call the KOT Hotline (780-481-2942 ext. 1) on the Friday before the rally by 9:00 pm and leave your name, phone number and address. The bus volunteer will call you on Saturday to tell you when and where your stop will be. Please have your phone on and available Saturday morning.
3. No bussing will be offered for the School Character Clubs. Parents are expected to pick up their children promptly at the end of the After School Clubs.
4. Kids On Track does **not** provide lunches for the School Character Clubs. We will however provide a take home snack at the end of the After School Clubs on early dismissal day.
5. Please discuss appropriate behavior and the consequences of inappropriate behavior with your child. The following behaviors are expected and if not demonstrated will be addressed with progressive consequences including: time outs, loss of tokens or treats, calls home, week's suspension, or a permanent suspension.
  - A. Respect leaders, other children and property
  - B. No violence including punching hitting, kicking or spitting etc.
  - C. No bullying
  - D. Listen and obey the leaders and the Kids On Track rules
6. You or your emergency contact person must be available to be reached during program times. Should your child need to be removed from the program it is your responsibility to provide an immediate pick up or assume any costs for transporting your child home.
7. Space in the School Character Clubs is limited. If your child misses two Clubs in a row with no communication from a parent/guardian, the child's name will be removed from the list and another child will take their spot. Please encourage your children to have regular attendance at these Clubs. You may contact Kristy the Program Coordinator at 780-481-2942 ext 3.
